In order to get an appointment to get your electronic monitoring bracelet on you need to have certain items turned in to the Alternative Sentencing Coordinator. After all these items are turned in, then and only then, will an appointment be made to get your bracelet on.

- 1) Payment in full. You will be charged a rate of \$10.00 per day. Acceptable forms for payment are CASH or MONEY ORDER.
- 2) A completed Intake Sheet which is attached to this sheet.
- 3) A signed and initialed Rules and Regulations Form which is attached to this sheet
- 4) If you are planning on working letter of employment verification on employer's letterhead stating hours of work (start and end time of each day) and days of the week worked, signed by a supervisor. Please note you can only work maximum 6 days/week, 12 hours/day.

Or attending school – a schedule printed on school letterhead signed by advisor or supervisor.

Treatment – letter from treatment facility stating days of the week you attend with start and end times for each class, on letterhead, signed by counselor.

You may bring in the above items anytime M-Th 8:00-2:00. At that point you may schedule your appointment to get your electronic monitoring bracelet put on. Any questions, please call.
