In return, I ask permission to work within the public right of way to remove noxious weeds and to remove brush by cutting and treating the stumps. A completed Permit to Work Within the Right of Way must also be on file with the Secondary Roads Dept. Roadside Vegetation Management or No Spray signs must be posted in **visible** locations at each end of the Maintenance Agreement area to define boundaries. Signs must have an unobstructed view from the road and must be a minimum of 5 feet above the ground. This agreement **does not** prohibit herbicide applications by utility companies or other entities.

I fully understand that I am to destroy State & County listed noxious weeds by **June 1<sup>st</sup> of every year**, and remove all brush and trees in accordance with Scott County Noxious Weed and Brush Control Policies, or the same may be removed by Scott County and this or future permits may be revoked if not in compliance with signed agreement. This is a long-term agreement, and is effective from date below.

I understand that it is my responsibility to notify Iowa One Call at 811 to have locates done in the right of way because there could be underground utilities where the signs are being placed. This is to protect myself and others from unintentionally hitting underground utility services that could cause serious damage. I will call at least 3 days before installation.

Sign placement should be top of the back slope 5ft tall. The post must be break away. The sign should face on-coming traffic so motorist can visibly see sign as they approach.

Each owner and each person in the possession or control of any lands within Scott County shall cut, burn, or otherwise destroy all noxious weeds, as listed below, each year and in such manner as to prevent said weeds from blooming or coming to maturity and as often as necessary to prevent seed production:

**May 20 to June 5:** Leafy spurge, hoary cress, curly dock, smooth dock, poison hemlock, red sorrel, purple loosestrife, and musk thistle

**June 1 to June 15:** Canada thistle, Russian knapweed, buckhorn plantain, and wild mustard

**July 1 to July 15:** Field bindweed, horsenettle, perennial sowthistle, quackgrass, velvetleaf, puncturevine, cocklebur, bull thistle, tall thistle, wild sunflower, and teasle

**Springtime:** Buckthorn (Rhamnus)
