- Emergency Child Care for Essential Workers
- Child Care in Illinois: Restore Illinois Phases 3 & 4
  - Reopening of child care in Illinois outside of emergency programs.
  - Care resumes for all parents.





## Illinois DCFS Licensing Requirements / COVID-19

#### (Effective May 29th, 2020)

- The Illinois Department of Children & Family Services is responsible for licensing oversight and enforcement.
- Prior to re-opening licensed programs submit Reopening Plan to DCFS detailing how provider intends to meet new health & safety standards.
  - Daily health checks for all persons entering program.
  - Limited entrance at drop off/pick up.
  - Cleaning procedures throughout day, at closing, and between shifts.
  - Plan to provide PPE for all staff & children and train staff on use.

- Enhanced Staffing Plan
  - Children are kept in same group and with same teacher/staff throughout entirety of day.
- Group Sizes
  - Reduced group sizes.
  - Groups cannot be combined at any time, including on playgrounds.



## Restore Illinois Child Care Guidance

#### (Updated August 17th, 2020)

- In addition to DCFS Licensing Regulations, additional child care guidance has been issued.
- Social Distancing Practices
- PPE Face Coverings
  - Effective 8/7/2020
  - Child care programs shall require children & staff over the age of two and able to medically tolerate a face covering to cover nose & mouth while on premises.

- Hygiene & Health Practices
- License Exempt Centers
  - Allowance of centers exempt from DCFS licensing requirements allowed to provide services for school aged children during remote learning days as specified by school district.

### Connecting Families with Child Care Financial Assistance-IL

### **Income Eligibility**

 Income for a new application must be at 200% or below of the Federal Poverty Level for a family to be income eligible for the Illinois Child Care Assistance Program (CCAP).

 All families pay a portion of the cost of care as a co-payment. The amount is based on income and family size. Families may be approved for full-time, parttime, or before after school care.

### **Eligible Activities**

- Parents/guardians are working and meet income requirements.
- Parents/guardians receive TANF and are in an education, training, or other work activity approved by caseworker.
- Parents/guardians are attending education or training activities including ESL, high school equivalence, GED, vocational training, and 2- and 4- year college degree programs.
